SAGE 300CLOUD PAVES THE WAY FORWARD

"Until recently, we had little integration of our back-office financials across our four corporate entities," explains Wayne Brinster, CEO of MedTest Dx. "Two of our brands were using older versions of Sage 300, and the other two were using separate applications. It made it exceedingly difficult to generate consolidated financial statements and have the necessary visibility into costs and profitability across our entities. Integrating our accounting systems across our business units became a high priority."

With the decision made to work toward integration, Brinster and Lenell Wyche, the company's CFO, had to decide on the solution that could unite their operations. "I had experience both with Sage and with SAP so we considered both," recalls Brinster.

"We determined that SAP was too big, complex, and expensive for our needs," says Wyche. "Speaking with our partners at Net at Work we formed a plan to update to the latest version of Sage 300cloud and begin migrating all our operations to that platform."

MedTest Dx felt confident in their decision based in large part on the trust they had built in Net at Work over the years, and the skillset of their primary consultant. "Our Net at Work consultant has been a great asset to our team, helping us with anything we need – from getting our system ready for website orders to preparing us for the transition of our systems to the cloud," says Brinster. As part of the implementation, the company moved from hosting the application on their own in-house servers to engaging Net at Work’s companion company, Cloud at Work, to host Sage 300cloud on a private cloud.

“We don’t have a large internal IT staff, so hosting makes tremendous sense to us,” says Brinster. “We need a reliable, fast system, that is accessible from anywhere and backed up automatically, and Cloud at Work is able to deliver that. We briefly considered having Microsoft host the application, but Cloud at Work simply made more sense.”

“Having Net at Work both host and support our accounting system is an ideal situation,” notes Wyche. “They have ownership of the whole solution, so there’s never any finger pointing – we have one company to call with questions or problems.”

PLANNING FOR THE FUTURE

Over the past several years, MedTest Dx has seen its operations grow and diversify, both through organic growth and acquisitions of complementary companies. With the move to Sage 300cloud, deployed as a hosted solution by Cloud at Work, the company is able to continue to scale, knowing its technology infrastructure can scale with it.

Currently, two of MedTest Dx’s individual entities have implemented Sage 300cloud, with the other two coming on board shortly.

“We are already realizing many efficiencies, including easy remote access, which is particularly important during the pandemic,” says Wyche. “As we consolidate all our operations under Sage 300cloud, the efficiencies will grow, providing us with the visibility and agility we need to continue our path forward.”
