64 vs. 32 Bit

- Sage 100 32-bit will be retired April 2026
- After installing the 64-bit version of Sage 100, any 32-bit versions on the same system will no longer be available
- If you install the 64-bit version of Sage 100 then only systems with the 64-bit version of Windows will be able to run Sage 100

64 vs. 32 Bit

Be aware when migrating from 32-bit to 64-bit

- Sage 100 needs to be V2021 or higher
- Confirm any 3rd party enhancements are compatible with 64-bit
- Understand 32-bit versions of Sage 100 cannot be on the same system as 64-bit
- Confirm all systems operate on 64-bit Windows
